### **MINUTES OF THE MEETING**

The basis for the denial is conviction history, failure to report convictions, and misrepresentation of material facts. ### Jasmine Alvaro - Body Artist

Request information includes: need a completed evaluation and information indication if she reported to Wyoming and Colorado. #### **Deborah Schlosser – Cosmetology Reinstatement**

Anderson moved, seconded by Nordboe, to recommend reinstating Schlosser's Cosmetology license with censure, \$1000 administrative penalty, \$1000 civil penalty to be paid within 1 year, and completion of the jurisprudence exam within 90 days. The basis for the censure, administrative penalty, civil penalty, and the completion of the jurisprudence exam is due to practicing for 665 days without an active license. # **Lora Davis - Cosmetology Reinstatement**

Bavougian moved, seconded by Nordboe, to recommend reinstating Davis' Cosmetology license with a \$1000 administrative penalty, \$250 civil penalty, and completion of the jurisprudence exam within 90 days. The basis for the censure, administrative penalty, civil penalty, and the completion of the jurisprudence exam is due to practicing for 150 days without an active license. Voting aye: Bingham, Bavougian, Kozisek, Reed, Anderson, Nordboe, Nims, Lucas, and Bain. Voting nay: none. Abstain: none Absent: none. Vacant positions: 4 Motion carried.

### Nouveau Nails - Cosmetology Salon

Anderson moved, seconded by Nordboe, to recommend the approval of the application for a Cosmetology Salon license with censure, \$4000 civil penalty to be paid over 4 years, and completion of the jurisprudence exam for the owner, Hoa Tran, within 90 days. The basis for the censure, civil penalty, and the completion of the jurisprudence exam for the owner is due to operating since 2021 without an active license. Voting aye: Bingham, Bavougian, Kozisek, Reed, Anderson, Nordboe, Nims, Lucas, and Bain. Voting nay: none. Abstain: none Absent: none. Vacant positions: 4 Motion carried.

### Studio NineSix-11 Salon - Cosmetology Salon

Anderson moved, seconded by Nordboe, to recommend the approval of the application for a Cosmetology Salon license with censure, \$1000 civil penalty to be paid within 1 year, and completion of the jurisprudence exam within 90 days. The basis for the censure, civil penalty, and the completion of the jurisprudence exam is due to the operation of an unlicensed facility. Voting aye: Bingham, Bavougian, Kozisek, Reed, Anderson, Nordboe, Nims, Lucas, and Bain. Voting nay: none. Abstain: none Absent: none. Vacant positions: 4 Motion carried.

### 7. UPDATES/FOLLOW UP

#### Legislation

Loving recommends forming subcommittees to review and revise the statutes pertaining to Cosmetology, Electrology, Esthetics, Nail Technology, and Body Art.

Bavougian suggested an extra meeting to discuss statute changes and reaching out to the senator to attend the meeting on November 3<sup>rd</sup>, 2025. Ord will extend an invitation to the senator.

Sandberg mentions that proposals for statute revisions that are to be introduced to legislation are due in July 2026.

### National Interstate Council of State Boards of Cosmetology (NIC)

Kozisek is unable to attend the NIC conference.

#### **Head Spas**

The board discussed that, pertaining to Hair and the Scalp, one would have to have a cosmetology license. Advisory opinion: There is no opinion at this time.
