Page 3: Paragraph 7 corrected to read:

Ameku stated that when statutes were drafted it was focused on patient-based examination not mannequin. Maybe it is time to look at alternative pathways to licensure such as PGY1 (Post Graduate Year 1) by successfully completing a PGY1 in Advanced Education in General Dentistry or General Practice Residency from a CODA accredited program. This will provide the Dentist an opportunity to gain additional experience and allow another option for obtaining dental licensure in Nebraska.

Page 3: Paragraph 8 corrected to read:

Steckelberg states she is open to finding other pathways to licensure. Such as, accepting an extra post graduate year after graduation, but that would not be equal for both dental schools in Nebraska.

REGULATIONS UPDATE

Clarification on Reciprocity Pathways for Dentistry:

NE Revised Statute 38-1117.

Dentistry; license; requirements.

(1) Every applicant for a license to practice dentistry shall (a) present proof of graduation with a Doctor of Dental Surgery degree or a Doctor of Dental Medicine degree from an accredited school or college of dentistry, (b) pass an examination approved by the Board of Dentistry which shall consist of the National Board Dental Examinations, both Part I and Part II, as constructed and administered by the American Dental Association Joint Commission on National Dental Examinations, (c) demonstrate the applicant's skill in clinical dentistry by passing the practical examination administered by the Central Regional Dental Testing Service or any other regional or state practical examination that the Board of Dentistry determines to be comparable to such practical examination, (d) pass a jurisprudence examination approved by the board that is based on the Nebraska statutes, rules, and regulations governing the practice of dentistry and dental hygiene, and (e) demonstrate continuing clinical competency as a condition of licensure if required by the board.

(2) Upon completion of these requirements, the department, with the recommendation of the board, shall issue the applicant a license to practice dentistry.

Dentist; reciprocity; requirements.

Every applicant for a license to practice dentistry based on a license in another state or territory of the United States or the District of Columbia shall meet the standards set by the board pursuant to section [38-126](#) and shall have been actively engaged in the practice of dentistry for at least three years, one of which must be within the three years immediately preceding the application, under a license in another state or territory of the United States or the District of Columbia. Practice in an accredited school or college of dentistry for the purpose of completing a postgraduate or residency program in dentistry also serves as active practice toward meeting this requirement.

Dental hygienist; licensed dental assistant; reciprocity; requirements; military license; temporary license.

(1) Every applicant for a license to practice dental hygiene based on a license in another state or territory of the United States or the District of Columbia shall meet the standards set by the board pursuant to section [38-126](#) and shall have been actively engaged in the practice of dental hygiene for at least three years, one of which must be within the three years immediately preceding the application, under a license in another state or territory of the United States or the District of Columbia. Practice in an accredited dental hygiene program for the purpose of completing a postgraduate or residency program in dental hygiene also serves as active practice toward meeting this requirement.

(2) An applicant who is a military spouse may apply for a temporary license as provided in section [38-129.01](#).

(3) Every applicant for a license to practice as a licensed dental assistant based on a license in another state or territory of the United States or the District of Columbia shall meet the standards set by the board pursuant to section [38-126](#) and shall have been actively engaged in practice as a licensed dental assistant for at least three years, one of which must be within the three years immediately preceding the application, under a license in another state or territory of the United States or the District of Columbia. Practice in an accredited dental assisting program for the purpose of completing a postgraduate or residency program in dental assisting also serves as active practice toward meeting this requirement.

UPDATE ON THE MEETING WITH THE DEANS

Cope commented that he would prefer that no exam be specified in the Statutes.

Good morning. My name is Timothy Tesmer, and I am the Chief Medical Officer for the Nebraska Department of Health and Human Services. It is an honor to be here. I want to express my sincere appreciation for the opportunity afforded me last week to speak to this Board. I will respect your time and agenda and keep my comments brief.

The mission of DHHS is to “help people live better lives” by ensuring the health, safety and welfare of our citizens. Broadly speaking, the Department and this Board should have a similar mission.

Currently, an opportunity exists to positively impact the alarming trend of the number of dentists in our state decreasing, while our overall population increases. Recruiting young dentists to our state is vital and critical. Currently, per state statute, one practical clinical licensing examination is listed as acceptable (CRDTS). However, the statute allows for “any other regional or state practical examination that the Board of Dentistry determines to be comparable to such practical examination”.

Comparable is not defined in the statutes. Plain English definitions of comparable include similar, like or close. Nowhere does the word “exact” appear in such definitions. We all know that no one test can assess complete or exact clinical competency for treating actual patients. The key is whether the test adequately assesses minimal competency to utilize the clinical skills necessary for dental practice.

I have been unable to find any disciplinary actions taken across jurisdictions based on a particular practical licensing examination one took to obtain a dental license. With this, I have considerable difficulty understanding any safety objections that would disallow the ADEX exam from being accepted, especially when nearly all other states in our country, with perhaps two exceptions, find it to be acceptable.

I humbly and respectfully ask this Board to thoughtfully consider its decision on acceptable practical licensing examinations, thereby providing Nebraskans expanded access to well-trained dental professionals who want to come live and practice in our state. The time is now to courageously act for the dental “health, safety and welfare” of our citizens. Thank you.

Ms. Cobler comments that the “DLOSCE” pathway contains no hands-on skills assessments.

DLOSCE is a computer-based examination requiring the candidate to answer 150 questions using 3D computer modeling to answer questions on clinical dental tasks and does not include a hands-on component.

OROFACIAL MYOLOGY SUBCOMMITTEE MEETING REPORT

Nebraska Board of Dentistry Subcommittee: Orofacial Myology
October 4, 2024 Report to Full Board

Nebraska Board of Dentistry Subcommittee on the Orofacial Myology Practice questions (7/12/24 BOD meeting) met via Zoom on 8/14/24 and 8/28/24. Subcommittee members in attendance were: Lisa Kucera, Dr. Takanari Miyamoto, Hannah Randell, and Dr. Melanie Steckelberg.

We also met via Zoom on 9/12/24 with the above individuals plus the following additional interested parties: Elizabeth Laney, BSDH, RDH and Patricia Brinkman-Falter, BSDH, MS, PHRDH, COM. These individuals were on record from the last BOD meeting as interested in working with this subcommittee. We finalized this report via email.

The subcommittee reviewed the practice questions posed and brings forth these recommended answers.

Q1. Is a myofunctional therapist required to work in a dental office under direct supervision or general supervision.

Recommended Answer 1. *If a myofunctional therapist is licensed as a dental hygienist, they are bound to the statutes of their licensed profession. Therefore, they are required to work with a dentist under general or indirect supervision. A Nebraska professional license dictates the scope of practice. Nebraska dentistry statutes do **not** include direct supervision.*

These minutes have not been reviewed or approved by the Board of Dentistry.

Q2. If a myofunctional therapist has additional training in manual therapy for TMJD from a licensed massage therapist and certified myofunctional therapist, can they provide manual therapy intraorally for TMJD if working on their own and not within a dental office?

Recommended Answer 2. No, that training would need to come from a CODA accredited institution.

Q3. Can a hygienist work as a myofunctional therapist under a 1099 independent contractor agreement within a dental office?

Recommended Answer 3. The Board of Dentistry does not comment on IRS classifications.

The subcommittee also brings forth these recommended statements:

1. Orofacial myofunctional therapy is the re-education of the orofacial complex: muscles, functions, and rest postures. This involves lips, tongue, cheeks, mandible, sucking, chewing, swallowing, speech articulations and more. Myofunctional therapy takes time to integrate via neurologic reeducation. Discharge of the patient occurs when the functions of the stomatognathic system are stable and new patterns have been habituated.
2. Receiving a Referral does not equate to general supervision nor indirect supervision.

If there are further practice questions, the subcommittee recommends going through the 407 process (change of practice scope).

Nebraska Board of Dentistry Subcommittee: Orofacial Myology

The dental profession needs to do a better job of working together. We are all better than this.
