A quorum being present, the meeting convened. DEPARTMENT OF AGRICULTURE UPDATES

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department was present via WebEx for discussion with the Board.

H5N1or Avian Influenza - to date no detections have been made in Nebraska since February in poultry, and still no reports in dairy cows or the human population. The State of California has reported twelve human cases of H5N1. No deaths have been reported and the most significant symptom being conjunctivitis side effects. The cases were reported in dairy workers, so this is not contracted by drinking milk but rather by making contact with the milk production.

South Dakota has reported a positive TB case at a slaughterhouse. The animal was traced back to Nebraska and is currently under investigation. Nothing has been reported in Nebraska.

North Dakota has reported an outbreak of anthrax. Nothing has been reported in Nebraska.

The USDA (United States Department of Agriculture) Animal Disease Traceability rule goes into effect November 5, 2024. https://www.aphis.usda.gov/livestock-poultry-disease/traceability The electronic ID tags are available to accredited DVM's in Nebraska.

2024 LEGISLATION UPDATES

Megan Kilgore, Executive Director of the Nebraska Veterinary Medical Association (NVMA) was present via WebEx for discussion with the Board.

LR375 - Interim study to examine different methods, including potential statutory changes, to address the need to recruit, train, and retain individuals who practice production animal veterinary services in Nebraska. https://nebraskalegislature.gov/FloorDocs/108/PDF/Intro/LR375.pdf

Hearing scheduled for November 1, 2024. Megan indicated that the NVMA will be testifying at the Hearing along with the Nebraska Department of Agriculture.

Currently there are discussions regarding the creation of a four-year veterinary school at UNL. The consideration would be how viable would a program in Nebraska be.

Dr. Byers suggested that the Board may be interested in reviewing an article in the August, 2024 edition of the Journal of the American Veterinary Medical Association (JAVMA) regarding a "Viewpoint" article which discusses an imminent need for veterinary medical educators.

The opinion of the Board is that Unlicensed Veterinary Assistants have no authority to perform this procedure.
