# MEETING MINUTES October 24, 2025

#### **2025 LEGISLATION UPDATES**

NMA is helping the State apply for the funds from the Rural Health Transformation Program (RHT). Nebraska should receive at least 100 million each year for five years. # PRESENTATION BY DR. PATTERSON, NEBRASKA MEDICINE

UNMC and NE Medicine are recruiting qualified and experienced physicians to serve as members of their faculty to participate in GME and clinical programs. Those physicians identified by UNMC and NE Medicine would submit the TVFP (Temporary Visting Faculty Permit). The applicant would need to be approved by the Board of Medicine and Surgery and the DHHS Department.

If the TVFP physician expresses their desire to stay in Nebraska for the long term, UNMC will assist the physician in gaining the necessary steps for permanent licensure.

# PRESENTATION BY CHARLIE SHEFFIELD, AMERICAN BOARD OF MEDICAL SPECIALTIES (ABMS)

The ABMS is the leader in Board certification for Specialty Medicine. There are 24 independent member boards, 38 specialties and 89 sub-specialties.

\*To qualify you must have achieved initial board certification:

There are **four** elements with one program:

- Professionalism and professional standing
- Lifelong learning and self-assessment
- Assessment of knowledge, judgment and skills
- Improvement in medical practice

# **Six** ABMS/ACGME core competencies:

- Medical knowledge
- Practice-Based learning and improvement
- Patient care and procedural skills
- Systems-Based practice
- Interpersonal and communication skills
- Professionals

FSMB (Federation of State Medical Boards) supports the use of and encourages state boards to recognize a licensee's participation in an ABMS Maintenance of Certification (MOC) program as an acceptable means of meeting CME requirements for license renewal.

Recognizing specialty certification for CME:

- Allows physicians to simply submit their certification status and certifying organization instead of submitting CME hours for potential review/audits
- Certifying organization confirms active participation in continuing certification for individual physician, ensuring participation in ongoing educational requirements

A. Can a licensed Esthetician use the Tixel machine for epidermal rejuvenation without a medical director?

The Board's opinion is that this procedure is the practice of medicine and surgery, therefore, to perform this procedure it would be necessary to be licensed as a Physician.
