NPAI (Highly Pathogenic Avian Influenza) has been reported in virtually all of the surrounding states to Nebraska, however there are no current reports in Nebraska at this time.

Rabies response has been authorized by the Department of Agriculture at the end of October to begin dropping bait and oral vaccine.
