#### **DEPARTMENT OF AGRICULTURE UPDATES**

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department, was present via WebEx for discussion with the Board.

**H5N1or Avian Influenza** – Fortunately for the fall season here in Nebraska, there have not been any detections. Earlier in September there was a detection in Central Nebraska, and the herd is currently in quarantine.

**New World Screwworm (NWS)** – To date NWS has not been detected in the U.S., but it is moving northward up from Mexico. The last detection was 170 miles south of the Texas/Mexico border. There are plans in place if NWS is detected in the U.S. Dr. Fritts would like to meet with the Board to further discuss a planned response for small animal treatment.
