
1. To view service authorizations for your organization, start by selecting the correct organization in the dropdown list.

Note: If 'Any' is selected your search results will return service authorizations for all organizations you are managing.

- 2. You have the ability search authorizations based on the type (New Service, Updated Service, Discontinued Service, or All). By default, New Service will populate.
- 3. To narrow your search further, you have the ability to enter client first name, client last name, client ID, and/or Service Authorization #. The more information you enter, the more defined your search results will be.
