Android phone: (Android Version Lollipop (5.0) or higher)

TABLET with GPS

# Getting Ready: Being Prepared cont.

ACCESS	REQUIRED/OPTIONAL	REASON
Location Services (GPS)	Required	For location of visit check-in/check-out.
WiFi Data	Required (Required (unless user accesses internet only mobile network)	For internet access
File Storage	Required	To store your data.
Mobile Data	Required (unless user accesses internet only via WiFi network)	For internet access


