# Electronic Visit Verification Update – Mary McMichael

- Working with procurement to prepare RFP for release
- Current Target date of February 2020 for implementation, pending Vendor schedule
- Internal work Continuing to review regulations which may need updates
- Evaluation training and communication needs for providers and participants
- We may ask for testers from this stakeholder group prior to implementation.

# State Transition Plan – Kathy Scheele

- Some settings may need to make changes to be in compliance with the new HCBS Final Rule.
- All AD Waiver settings have been assessed.
- All settings must be in compliance by 3/17/22 if they want to be HCBS compliant.
- Working on remediation forms to be in compliance.
- DD is hoping to be through their settings by mid-January
- There will be a Public Comment period prior to submission to CMS for final approval.
- The Final Rule does not allow those providing services to also assess for the Level of Care, as this would be a Conflict of Interest.

### Children's Level of Care – Kathy Scheele

- The Pediatric Nurse at DHHS will continue completing Level of Care
- Prior to December 2018, we did not have regulations for assessing a skilled level of care specifically for children.

### Nursing Facility Pay for Performance – Dr. Van Patton

- The current payment methodology is based on facility costs, census and appropriation changes. It does not factor in quality of care provided.
- Look at outcomes from diagnosis to prescriptions which leads to good data studying.
- Look at quality and continuity of care.
- What is happening in the marketplace?
- Nebraska has a rule of law, with a payment method in the regulations, and we have to follow it.
- Pay based on utilization

- Create a system of rewards
- Payment model that makes high levels stay there and lower to move up

# National Core Indicators – Stephanie Crouch

- We will present results from last survey in March meeting
- We are one of the first states to add a Person Centered Planning Module.
- Sending out an introductory letter helped pave the way for our surveyors reception.

### TBI Renewal

- CMS approved an extension to March 31st
- We are open to more providers.
  - No one else has applied
- We are aware there is a desire for TBI services in the home.

# MFP Sustainability

- We are looking at expanding the Home Again service currently in Waiver
- We realize a Tenancy service is needed

### Other Points

- Currently the Fiscal Agent will be used with AD Waiver Services
- Possible also used with Lifespan Respite
- Senator signed the Children's Level of Care on December 19, 2018
- Much discussion ensued from families with children
- It was explained that this change was made to become compliant with CMS rules to maintain our Waiver grant
