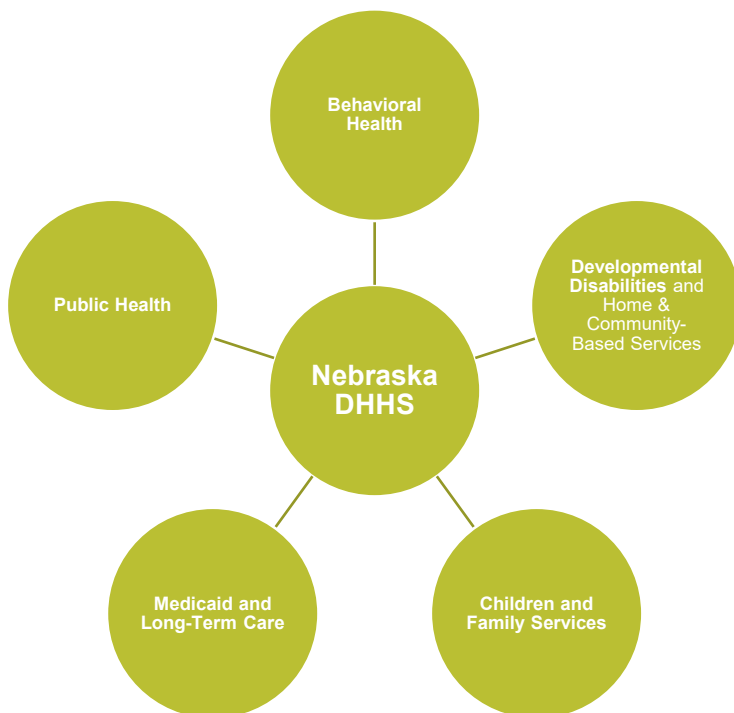


## DHHS Tribal Liaisons
