2018 Nebraska Public Health Authorization Dental Services Report

One hundred and ten (110) registered dental hygienists (RDH) were mailed questionnaires regarding usage of the Public Health Authorization (PHA) or Public Health Authorization-Child (PHA-C) during 2018. The 110 included RDHs who either held a PHA or PHA-C permit at the end of 2018. No permits expired during 2018.

Of the 110 RDH sent questionnaires, 96 held a PHA and 14 held PHA-C. Eighty-six (86) responses were received, 78 PHA and 8 PHA-C, reflecting a 78% response.

Forty-three (43) RDHs provided services in 2018, indicating that 39.1% of RDHs who held a PHA or PHA-C during 2018 utilized the permit. Services were provided in 64 of the 93 counties in Nebraska. Services were provided in the following locations (number of RDHs reporting this location type):
