RE: Non Support of Credentialing Application to License Certified Anesthesiologist Assistants in Nebraska

On behalf of Colorado Association of Nurse Anesthetist (COANA) I am writing to strongly discourage support of Licensure for Certified Anesthesiologist Assistants (CAA) in Nebraska.

CRNAs provide the same high quality, safe, and cost-effective care to that of anesthesiologists. Moreover, in Colorado as in Nebraska, rural areas depend disproportionately on CRNA services for anesthesia and pain management care and the surgical, procedural and labor and delivery services that such care affords. Recently the Nebraska Society of Anesthesiologists (NSA) wrote a support letter stating that CAA have "identical patient care responsibilities and technical capabilities- a view in harmony with their equivalent treatment under the Medicare Program." As you have seen from the many letters of Rural Hospitals, this is not the case. The NSA also stated that other neighboring states, such as Colorado Licensed CAAs.

Since the licensure of CAA's in Colorado, we have not seen an increase in access to care by adding another type of anesthesia provider. What we have seen in our state after licensure of CAAs is an increase in workplace dissatisfaction due to professional politics, withdrawal of SRNA students at clinical sites, and the inability to recruit CRNA to companies along the Urban Corridor of Colorado thus leading to inability to staff many of the contractual Surgical Service Sites resulting in loss of Anesthesia contracts and delayed patient care. Licensure of CAAs in the state of Colorado has not had the impact that the NSA would lead you to believe.
