<u>Online License Renewal:</u> You may renew your license online at https://nebraska.mylicense.com/ To register on-line you will need your license number, your social security number and a credit or debit card with a MasterCard or Visa logo.

<u>Failure to Submit Renewal by Expiration Date:</u> If you fail to submit a completed renewal by the expiration date, your license expires. To practice after this date, your license must be reinstated. If you practice without an active license, an administrative penalty of \$10 per day up to \$1,000 will be assessed for each day of practice.
