#### 2023 LEGISLATION UPDATES

Amy Reynoldson, Executive Vice President and Paul Henderson, Vice President, Advocacy & Regulation; Inhouse Counsel with the NMA (Nebraska Medical Association) were present to discuss and provide updates to the Board.

The 108<sup>th</sup> Legislature, First Regular Session convened January 4, 2023. 820 Legislative Bills were introduced and the NMA discussed the following Legislative Bills with the Board:

### **REGULATIONS UPDATE**

Title 172 Chapter 90 Licensure and Supervision of Physician Assistants proposed draft revisions regarding the passage of LB390 Reciprocity were reviewed by the Board. Kuenning moved, seconded by Blake to approve the proposed draft regulations as written. Voting aye: Blake, Hedrick, Howorth, Kuenning, Massey and Michaelis. Voting nay: None. ### MATERNAL DEPRESSION SCREENING

At the January meeting the Board heard a presentation by Sydnie Carraher, APRN-NP, Program Administrator NPQIC (The Nebraska Perinatal Quality Improvement Collaborative) and Sara Howard, J.D., Policy Associate, First Five Nebraska regarding "maternal depression screening" and the Legislative Bill 905 from the last session, which was passed into law as Nebraska Revised Statute 38-2064 effective July 21, 2022: https://nebraskalegislature.gov/laws/statutes.php?statute=38-2064

The Purpose is to Authorize the Board of Medicine and Surgery to work with accredited hospitals and licensed health care professionals to create policies to facilitate perinatal mental health screening.

At the January meeting the Board voted to develop a draft "Letter of Support" to be reviewed and approved by the Board at their next Board meeting to submit to the Legislature.

## ADVOCATE FOR A PHYSICIAN HEALTH PROGRAM (PHP)

The Board held discussions at the January meeting regarding the development of a PHP for Nebraska.

Support needs to be established and model language needs to be proposed for a legislative bill and sponsorship to move forward with this initiative.

The Board voted to support the formation of a Nebraska PHP and to draft a "Letter of Support" to be reviewed and approved by the Board at their next meeting.

The proposed draft letter was reviewed by the Board. Massey moved, seconded by Blake to approve the "Letter of Support". Voting aye: Blake, Hedrick, Howorth, Kuenning, Massey and Michaelis. Voting nay: None. Absent: Goodman and Keegan. Abstain: None. Motion carried.

### BRIDGE TO MENTAL HEALTH

Dr. John Mitchell, Dr. Bill Lydiatt and Dr. Rodney Markin were present at the meeting to discuss with the Board "Bridge to Mental Health" a Nebraska mental health workforce expansion project. The presentation was the following:

This workforce expansion project will analyze, document, and communicate all aspects of considering, recommending, and implementing the creation of clinical resources proposed as a Bridge to Mental Health for patients experiencing mild to moderate depression and anxiety.

Bridge to Mental Health would offer additional mental health training to primary care and specialist providers to diminish workforce shortages until a transition to psychiatric specialty services can be achieved when necessary or avoided altogether when possible.

This proposal aims to establish access to effective, competent resources for patients experiencing mental health challenges in the absence of an available psychiatrist psychologist or social services.

In the State of Nebraska depression and anxiety exist in strikingly high rates among the poor, low income and young people. Suicidal ideation is also trending up in Nebraska. Access to mental health providers is a problem as is just in time care.

This workforce expansion project proposes a novel pilot to train primary care and specialist physicians and advanced practitioners.

The project's goal is to expand the training these providers already have and update their current knowledge. This will increase their diagnostic and therapeutic skills to help manage and provide early intervention to those who otherwise cannot gain access to mental health care.

Focused education will assist providers in mitigating the crisis of access by initiating early mental health treatment in areas where patients and the public already come for care.

The goal is to deliver enhanced training through a two-day seminar, supplemented with ongoing support from psychiatrists from Massachusetts General Hospital, and continued education through online and virtual offerings from Behavioral Health Education Center of Nebraska (BHECN) and local psychiatry training programs.

Access to additional sessions, the Massachusetts General Hospital Psychiatric Pharmacology library, and personal mentorship will follow this education.

This initiative will be seeking grant funding to obtain financial resources needed to complete education and conduct three cohorts of education for 10-15 providers.

To test the hypothesis that some practicing providers would seek additional training and determine the benefit of physicians addressing mild to moderate depression and anxiety, the project would:

- Conduct qualitative interview and survey as well as obtain pre and post-training findings to quantify the level of comfort and competence with managing these patients.
- Determine patient satisfaction by conducting pre and post treatment survey.

## FEDERATION OF STATE MEDICAL BOARDS (FSMB) ANNUAL MEETING

The FSMB meeting is scheduled to be held in Minneapolis, MN May 3-6, 2023. The Board members will review their personal schedules and decide if they will be able to attend the meeting. The Board will make the decision at the February meeting who will attend and who will represent the Board as the Voting Delegate.

## DEPARTMENT UPDATES ON NATIONAL ORGANIZATION PROGRAMS

IMLC – will be holding an Executive Director's meeting on January 30, 2023 in Texas. Jesse is on the Executive Committee and will be attending virtually. Dr. Michaelis is on the Communication Committee. Discussions will be centered on working on improving the licensure process with feedback from several surveys. This meeting will be a joint meeting with AIM (Administrators In Medicine), which Jesse is the Central Regional Representative.
