Dexter Schrodt, JD, VP Advocacy & Regulation, In-House Counsel, with the NMA (Nebraska Medical Association), was present to discuss and provide updates to the Board on the 107th Legislature, 2nd Session.

Dexter provided information on some of the legislative bills that the NMA is following that may be of interest to the Board. He indicated that discussions are being held on recommendations for the use of the ARPA funds (American Rescue Plan Act of 2021).

LB 741 Change provisions of and provide for review of stillbirths under the Child and Maternal Death Review Act (Adds stillbirths to the scope of the Child and Maternal Death Review Team)

LB752 Adopt the Alzheimer's Disease and Other Dementia Support Act, the Licensed Professional Counselors Interstate Compact, and the Occupational Therapy Practice Interstate Compact, require notifications regarding stem cell therapy, and redefine respiratory care under the Respiratory Care Practice Act (Updates the scope of practice for respiratory therapists to reflect their training on the ECMO machine) Referred to Health and Human Services Committee

LB 753 Require health care practitioners to provide notification regarding stem cell therapy

(Requires a health care provider to obtain informed consent for human stem-cell based therapy that the patient understands the treatment is not approved by the FDA)

LB767 Adopt the Pharmacy Benefit Manager Licensure and Regulation Act

(Prohibits PBMs and insurers from restricting pharmacies from disclosing any information they may deem appropriate for the patient to know, including the process of utilization review, any information on financial incentives or structures used by the insurer, the total cost of treatment or from presenting a more affordable alternative for the patient. PBMs are prohibited from requiring a patient to pay an amount greater than the lesser of the patient's cost-sharing or the amount a person would pay if paying for the cash price of the drug. Places restrictions on pharmacy auditing entities employed by PBMs. Prohibits PBMs from requiring information to be written on a prescription beyond what is required by law. Prohibits PBMs from placing a drug on a maximum allowable cost price list unless the drug is available for purchase from a wholesaler and is not obsolete. Prohibits PBMs from reimbursing a 340B entity at a rate lower than that paid for the same drug to similar pharmacies that are not 340B. Prohibits PBMs from excluding a pharmacy from the PBM's specialty pharmacy network if the pharmacy holds a specialty pharmacy accreditation.)

LB 852 Require behavioral health points of contact for school districts

(Requires school districts to designate a behavioral health point of contact who is to be a resource for providing students with available behavioral health resources and assistance in the community) Referred to Education Committee

LB885 Require implicit bias training for certain applicants and credential holders under the Uniform Credentialing Act

(Requires implicit bias training be completed annually for health care professionals)

LB906 Require employers to provide for vaccine exemptions and provide duties for the Department of Health and Human Services

(Requires DHHS to create a vaccine exemption form for the public to fill out, and further requires employers who may institute a vaccine mandate to accept the exemption form as proof that an employee has a moral, ethical, or philosophical belief against the vaccine.)

LB963 Adopt the Medical Ethics and Diversity Act

(Declares that health care practitioners, health care institutions, and health care payers have the right not to participate in or pay for any health care service which violates their conscience. Prohibits discrimination against such practitioners, institution, or payer for declining to provide a health care service based on their conscience. States that religious practitioners, institutions, and payers have the right to make employment, staffing, contracting, and admitting privilege decisions consistent with its religious beliefs.) LB1086 Adopt the Chemical Abortion Safety Protocol Act

(Prohibits use, dispensing, and administering of an abortion inducing drug for the purpose of inducing an abortion by a physician if the pregnancy is more than 49 days of gestational age. Mandates a physician examine the pregnant woman in person, verify a pregnancy exists, document in the medical record the gestational age and intrauterine location of the pregnancy, determine the woman's blood type and if Rh negative offer to administer Rho GAM at the time the abortion inducing drug is administered. Requires a physician to schedule a follow-up appointment with the woman, and send notification to DHHS about the administration of the abortion inducing drug. Makes it a Class IV felony to intentionally and knowingly violate these requirements.)

The proposed draft Regulations of Title 172 Chapter 87, Licensure of Surgical First Assistant are with the Governor's office for review as of March 23, 2022.

Title 172 Chapter 88, Licensure of Medicine and Surgery and Osteopathic Medicine and Surgery are currently being reviewed for revisions to the Re-entry sections.

Title 172 Chapter 89, Practice of Acupuncture, Chapter 90, Licensure and Supervision of Physician Assistants and Chapter 91, Licensure of Perfusionists are all currently being reviewed for revisions regarding the passing of LB390 regarding reciprocity.

COMPARISON of the STANDARDS of the UNITED KINGDOM "GENERAL MEDICAL COUNCIL" (GMC) QUALIFICATIONS for LICENSURE as to ACGME (ACCREDITATION COUNCIL FOR GRADUATE MEDICAL EDUCATION) QUALIFICATIONS for LICENSURE

The Board reviewed the ACGME (United States) and GMC (United Kingdom) training programs and board certification requirements for licensure in Nebraska. Goodman moved, and Blake seconded the opinion of the Board that the GMC requirements meet the requirements for Nebraska licensure the same as the ACGME. The identical statutory waivers and conditions contained in Executive Order Nos. 21-12 and 21-15 shall continue through September 30, 2022, except that Medication Aide renewals will no longer be deferred after March 31, 2022.
