Access to care issues that the NMA will be preparing to meet with Medicaid regarding:

- Photo screening and vision screening recommended for children ages 1-5 years
- Dialysis for undocumented people for treatment care costs

NMA is also continuing to consult with the FSMB and other States regarding their Physician Health Programs (PHP) to develop a PHP for Nebraska. The NMA will also be reaching out to the AG's office. Wisconsin and Nebraska are the only states currently that do not have a PHP.

Truth in Advertising – legislation that enforces health care professionals to introduce themselves to the public under their appropriate license affiliation. The concern is for the health care professional engaging with the patient to introduce themselves appropriately, for example as a MD or DO or APRN or DPM, etc. to avoid deceptive practices or miscommunication. This also includes online advertisements.

Basis for the denial is that there is insufficient evidence to change the original agreed upon probationary period that was set forth in the Agreed Settlement dated July 25, 2019. BOARD DISCUSSION(S)

A. Concerns regarding safety of the public for procedures provided by Unlicensed providers.
