## 4. Updates/Follow-up

a. Body Art Regulations 172 NAC 44 Hearing Update (8.29.2022) and Board Approval: Chiles provided an update regarding the public hearing for Chapter 44, 45 & 46. These regulations relate to the licensing of body art facilities and body artists (body brander, body piercer, permanent color technologist, and tattoo artist). Chapters 45 & 46 are being repealed and combined into chapter 44. There have been 2 public hearings held, 1st hearing was on October 10, 2019. Due to the number of comments received at the 1st hearing and the revisions approved by the Board, a 2nd public hearing was held on August 29, 2022. There were no comments received at the 2nd hearing.

Next steps: Approvals by the Board; Director of the Division of Public Health, Board of Health, Attorney General's office, and Governor.

Criswell updated the board that she contacted Milady & Pivot Point regarding the definition of microneedling (and similar names for same procedure) and where in the textbook the definitions could be found. Micro-needling is also referred to as: The board approved: Collagen Induction Therapy-(CIT), Dermarolling, Dry needling, MicroChanneling, MesoStamping, Needle dermabrasion, & Skin Needling

The board then discussed and suggested the definitions be included with the advisory position as references.

## 1. Milady:

12<sup>th</sup> edition of *Milady Standard Esthetics: Fundamentals*. ISBN 9781337095020. page 670 and 700 of the printed textbook.

#### The definition is:

Micro-needling, the use of a dermal roller or an electronic hand-piece to induce puncture wounds to the skin that induce collagen formation during the wound healing process".

#### 2. Pivot Point:

1st Edition, 1st Printing, December 2020, *Pivot Point Fundamentals: Esthetics*, ISBN 978-1-951862-15-2.

Section: 108E.1 page 10.

#### The definition is:

Dermal rolling, also referred to as "micro-needling," is a collagen induction therapy applied to rejuvenate the skin. This device uses very fine needles to puncture the surface of the skin, which triggers the skin to create new collagen.

3. **Devices Allowed Nebraska:** Needles Up to: 0.5, .5, or .50mm is Acceptable, Larger needles are for Medical use Only.

Public had a question relating to lightening and removal of permanent make-up/tattoo. It doesn't fall under the definition of tattooing, as no pigment is used as it is a saline solution, the board advised this is not within scope. Chiles will reach out to the Medical Board for information.

#### Statute references:

38-1044. Permanent color technology, defined. Permanent color technology means the process by which the skin is marked or colored by insertion of nontoxic dyes or pigments into or under the subcutaneous portion of the skin upon the body of a live human being so as to form indelible marks for cosmetic purposes.

38-1054. Tattooing, defined. Tattooing means the process by which the skin is marked or colored by insertion of nontoxic dyes or pigments into or under the subcutaneous portion of the skin upon the body of a live human being so as to form indelible marks for decorative or figurative purposes.
