#### NEBRASKA BOARD OF PHARMACY MEETING MINUTES November 7, 2022

### Pharmacist Reinstatement After Discipline Application(s) (1)

Kester moved, seconded by Beck, to recommend reinstating the pharmacist license of Michael Reeder (#16622) on probation for 24 months with the following probationary terms and conditions:

- Comply with all other disciplinary actions;
- Follow treatment and aftercare recommendations;
- Submit random body fluid screens;
- Inform all healthcare providers of your past treatment history and any prescribed controlled substances;
- Follow all other probationary terms and conditions sanctioned pertaining to someone with controlled substance use disorder; and
- Any inactive practice periods will not reduce the probationary terms and conditions or the timeframe.

Dr. Mueting asked about what needs to be provided to the Board for the pharmaceutical care agreements under the Neb. Rev. Stat. §38-2867.03 and how the NPA can help make it clearer for their membership. Mr. Cushman will review the statutes.

Dr. Dering-Anderson mentioned that some entities do not provide their protocols because they could be proprietary. Mr. Cushman and Dr. Mueting will work together on what needs to be in the pharmaceutical care agreements given to the Board.

### LEGISLATION UPDATE

Tomlinson asked Marcia Mueting, R.P., PharmD, Nebraska Pharmacists Association (NPA) if there was any discussion on legislative issues for the next legislative session.

Dr. Mueting explained that the NPA Legislative Committee has not formally approved legislation. Some to the legislation topics discussed prohibiting white bagging, pharmacists to achieve provider status, increasing dispensing fees under Medicaid. Dr. Mueting also mentioned that a 407 Credentialing Review to add language regarding USPS 795, 797, and 800 will be coming.

# **REGULATIONS UPDATE**

Mr. Cushman explained that another public hearing will be scheduled for 172 NAC 131 and 172 NAC 134. The regulations on 175 NAC 8 and 172 NAC 128 are still in process.

### NALOXONE DISPENSING FROM A DELEGATED DISPENSING PERMIT

Cushman explained that the Chief Medical Officer approved adding Naloxone to the Public Health Clinic's formulary and there was a question about dispensing under a standing order. Dr. Mueting mentioned that in August of 2022 the signature was updated.

# CLARIFICATION OF WHO CAN DISPENSE UNDER A DISPENSING PRACTITIONER LICENSE

Tomlinson mentioned that he has noticed lately noticed that Nurse Practitioners have been dispensing under a Doctor's dispensing permits. Cushman explained that he is working with the pharmacy inspectors regarding educating when visiting pharmacies for inspections. Hampton, Depart Legal, also recommended adding guidance documents to the Department's website. Dr. Dering-Anderson explained that sampling and dispensing is defined in the statutes so there is a need to keep them as separate issues.

The next NABP Annual Meeting is scheduled for May 10-12 in Nashville, Tennessee.

### NABP - DISTRICT V MEETING (AUGUST 2022) - REPORT

District V meeting discussions included discussing needed changes to the states MPJE. Beck explained that Accreditation Council of Pharmacy Education (ACPE) suggested that all state's stop requiring the MPJE for licensure. Other discussion included offering the state MPJE after the third year of education.
