# MINUTES OF THE MEETING OF THE BOARD OF VETERINARY MEDICINE AND SURGERY

### **REGULATIONS UPDATE**

Roger Dudley, DVM, Nebraska State Veterinarian and Animal Health Administrator was present at the meeting to discuss the proposed changes with Regulations.

The Board discussed proposing revisions for the Veterinary Medicine and Surgery Regulations, Title 172 Chapter 180. The Board is proposing revision to the "Surgery" definition as listed in 002.08 and adding "Suturing" to the list of tasks for a Veterinary Technician under "Direct" supervision as listed in 004.01(B).

The items suggested for proposed additions to the lists of tasks are as follows:

- Adding to the tasks under Immediate Supervision 004.01(A):
  - Intraosseous catheterizations
- Adding to the tasks under Direct Supervision 004.01(B)
  - closing of skin tissue as directed by the veterinarian
  - thoracocentesis, abdominocentesis, excluding pericardiocentesis
  - suturing or closing of gingival tissue as directed by the veterinarian

The proposed change to the definition of "Surgery" defined in 002.08 would be the following:

The treatment, through revision, destruction, incision, closure except as permitted in this chapter, or other structural alteration of animal tissue.

Jesse Cushman, Program Manager will submit the proposed revisions for review as soon as reasonably appropriate.

### 2022 LEGISLATION UPDATES

There were no Legislation updates at this time.

### AAVSB CONFERENCE

The American Association of Veterinary State Boards (AAVSB) held their Annual Meeting & Conference in Charlotte, NC on September 15-17, 2022.

Dr. Farrington a member of the AAVSB Bylaws Committee, attended the meeting representing the AAVSB in that capacity. At the meeting Dr. Farrington was elected to serve on the International Council for Veterinary Assessment (ICVA) as an (AAVSB) representative for 2023.

Dr. Byers represented the Nebraska Board at the meeting as the Voting Delegate. Dr. Byers was elected to serve on the Regulatory Policy Task Force for the AAVSB for 2023.

Mindy Lester, Assistant Attorney General also attended the meeting as legal counsel, representing the Nebraska Board and the Department.

The next Annual Meeting & Conference will be held in Kansas City, September 28-30, 2023.

Dr. Byers noted that suggestions for changes to the AAVSB bylaws will be due in March 2023.
